### President's Message | Jim Dea - ERA Advantage Realty

The Great Falls Association of REALTORS® is an excellent supporter of our community's children. I am very proud of how we've helped the homeless children of our community through our involvement with Stand Up for Students.



Over the past five years the Great Falls Association of REALTORS® has given over 22,000 toiletry items and \$39,500 to our homeless students. On Tuesday, November 21st GFAR presented a check for \$11,000 to the Great Falls Public Schools Foundation to help with this cause. My chest swelled with pride as I participated in the ceremony along with some of my fellow Realtors, affiliates and our CEO Terry Thompson.

While we have done great things, there is still more to do. It absolutely broke my heart on November 20th when I read in the paper and saw on the news the tragic death of Antonio "Tony" Renova - a five-year-old boy that died at the hands of his own parents and a third party here in our own city.

Great Falls is my hometown and I'm very proud of the city in which I grew up, but there are times when I question how such evil can occur right under our noses and nobody notices it. Even worse, if it is noticed and no one says or does anything. This recent tragedy has me asking what else can we do? What else must we do to help the children of our community?

Here are some statistics that shocked me. After speaking to a friend, Mike Ammons, from Child Bridge (a non-profit organization that finds and equips foster and adoptive families for Montana's children who are victims of abuse and neglect), I was shocked to learn that in the United States there are approximately 450,000 children in foster care. This means that one out of every 743 citizens in the nation is a child in foster care. Montana's ratio is worse, one out of every 322 Montana citizens is a child in foster care. Cascade County is even worse, in our own county one in every 137 citizens is a child in foster care. Cascade County is the worst county in one of the worst states in the tragic foster care debacle.

When I asked Mike what I could do to help, he said, "That's easy. We need more families to step into the gap and become foster families. We need foster parents that will help take foster children until they are either reunited with their parents, which is always the goal, or until they can be adopted." Another way we can help is to support organizations like Child Bridge, the Dandelion Foundation, or Toby's House Crisis Nursery are just three that I know are legitimate organizations. I'm sure there are many other organizations that legitimately will genuinely care for the children of our community, but not all that claim to do so really do. Please be careful with your money as there are illegitimate GoFundMe pages and other fundraising organizations that are not legit. Below you'll find the contact

information for the three that I mentioned.

This is the season of giving. The season that I remind my fellow men to keep Christ in Christmas. I challenge each of my brother and sister Realtors to do what they can to help this devastating crisis in our community. ERA Advantage Realty is going to encourage each Realtor to donate something from every closing to Child Bridge. I challenge each broker/owner to see what they can do to help this cause. I, as the broker/owner, made the commitment to match dollar for dollar anything that my Realtors donate. Please don't leave it up to the Association. Realtors are supposed to be involved in their communities and the children in our community need our help. Let's see what kind of difference we can make for the most defenseless members of our society. Let's report at the end of the year about what a difference the Realtors in our community made to help the children of Great Falls!

# **SentriKey Lockbox Service Information**



#### **Low Battery Notifications**

SentriKey is experiencing a higher number of low battery notifications at this time. If you receive one, we encourage you to bring the lockbox to the Association office to exchange it for a new box.

If your property is located out of town, we are happy to provide you with a box to take to the property to exchange as long as the process is completed in the same day.

#### **Lockbox Service Rules, Violations & Fines**

<u>Section 1.2 Issuance of Lockboxes:</u> Each participant or subscriber to whom lockboxes are issued shall sign a Lockbox Usage Agreement. Lockbox Usage Agreement executed by Subscribers (non-principal brokers, sales licensees) will be co-signed by the Participant or designated REALTOR®. A lockbox shall be placed on a listing within two (2) business days from time of issuance. (Section adopted by GFAR by 09/11)

Section 1.3 One Day Codes: Great Falls Association of Realtors® authorizes the use of one day codes to access lockboxes at the discretion of the Participant and/or Subscriber. Agents, contractors, unlicensed assistants, and other trades people may be provided a one day code by the Participant and /or Subscriber. When assigning codes in the lockbox data base system, the first and last name of the person and the name of their business or other like description must be included. \*Examples: John Doe, ABC Inspections; John Doe, Energy West; Jane Doe, ABC Cleaning Services (GFAR 10/13, Amended 02/17)

<u>Section 1.5 Removal of Lock Boxes:</u> All lockboxes must be removed within two (2) business days after cancellation or expiration of a listing agreement or the closing of a sold property. Withdrawn listings are allowed to retain the lockbox for a 14 day grace period. If the listing status hasn't changed after the grace period ends, the lockbox is to be removed or transferred within two (2) business days. (Amended by GFAR 09/11)

GFAR Staff will notify the member who is assigned ownership of the lockbox in violation as a courtesy via email, with a 48 hour deadline from

issuance. Failure to comply with any of the above rules beyond the deadline imposed will result in a penalty of \$25 per incident.

#### **Equipment Replacement Costs:**

Lost/Stolen/Significantly Damaged Lockbox: \$100 Non-Warranty Damaged Lockbox (ie. Cracked Faceplate): \$35 Lost/Stolen/Damaged Lockbox Shackle: \$10 (GFAR 02/13, amended 10/13, 09/15, 12/15, 02/17, 09/17)

As a friendly reminder, per the Lockbox Usage Agreement signed upon becoming a member of the Great Falls Association of REALTORS®, while the lockbox is under your ownership, you assume responsibility for its care. Damage to the lockboxes will be invoiced to the member responsible.

Pictured are cracked faceplates with a cost of \$35 each.

Additionally, gluing them back together will not skirt the charge, and can end up damaging the electronics inside the box, so please don't attempt this.

## 2020 Committees - Which One is Right For You?

### **Committees**

**Budget & Finance** – develops annual budget for the Board of Directors and Members. Researches non-dues revenue sources and monitors balance of income to expenses. Committee meets the second Thursday of every month at 10:15 am.

**Government Affairs** – keeps members informed of political and government policies/activities, promotes private property rights, solicits contributions for political interests and the issues mobilization fund. Determines where funds might be best used for candidates or issues. Meetings are scheduled on an as-needed-basis.

Great Falls REALTORS® Flag Project – A separate non-profit company owned by GFAR. Partners with Montana Air National Guard volunteers to keep the Flag in repair, flying, and manages fund raising. Coordinates the annual Essay Contest for 4<sup>th</sup> Grade students, Flag Day celebration on June 14th at Overlook Park, and the annual golf tournament in Sept. Meetings are scheduled on an as-needed-basis.

Grievance/Professional Standards – (requires professional standards training) The Grievance committee reviews Code of Ethics complaints and refers valid complaints to the Professional Standards committee. You must be a REALTOR® in good standing for three years before you can serve on the Grievance Committee. The Professional Standards committee is a hearing panel that hears matters of unethical conduct by members and provides arbitration as requested. You must have served on the Grievance Committee for two years before you can serve on Professional Standards. Meetings are scheduled on an as-needed-basis.

MLS Advisory Board – (appointed by President) the members of this committee must be Participants (Broker/Owner) of the MLS, or a broker-appointed designee.
Oversees the lockbox system used by REALTORS® and provides input regarding the MLS software program managed by the MRMLS. Committee meets quarterly on the first Wednesday of January, April, July and October at 10:00 am.

Young Professional Network (YPN) - is a valuable resource for those who want to build relationships with peers, advance their careers, and make a difference in their industry, community, and local association. REALTOR® Magazine launched the YPN in 2006 as an outgrowth of the popular "30 Under 30" feature with the goal to help the younger generation of REALTORS® build a stronger link with the real estate industry and expand networking and business opportunities. It's not required you be under 30! Meets monthly on the second Tuesday of every month at 1:00 pm.

### **Task Forces**

**Stand Up For Students** – created in 2015, Stand Up For Students (SUFS) hosts an annual toiletries drive for homeless students in our community. Additionally, the task force hosts fundraisers throughout the year, and on October 10<sup>th</sup> – World Homeless Day. To date, this task force has raised \$39,500 for the Great Falls Public Schools Foundation. Meetings are scheduled on an as-needed-basis.
